APM agrees with the need to take a regional and national approach and good projects already factor this in. Circumstances differ from region to region, and the regional approach captures needs of Islanders and others away from major conurbations. At the same time, the national interest must be accommodated throughout – the two are linked – and often complement each other. Infrastructure improvements and bypasses built for national interests can end up supporting regional development as well.

We would suggest an international approach as well – how will these projects link in with UK-wide and international transport projects? How can we better exploit the infrastructure projects currently being planned for Northern Ireland, England and Wales? The strategic transport links section touches upon this a little, and we discuss this more in our answer to that section.

We'd like to see a better appreciation of the role project professionals play in ensuring these projects will be built on scope, on time and on budget. And we're keen to work with the Scottish Government to ensure that they have the best possible chance of success. To that end, APM recommends:

- Greater emphasis on skills development, training and retention – the suggestions above will take time to implement and with project management skills in short supply it is clear more work will need to be done to increase supply.

- Learning legacy – the sheer number of projects that make up the STPR2 means this is a golden opportunity to learn from, and provide evidence on what makes projects succeed – it'd be good to collect this data and analyse it. APM has worked with major projects like Crossrail and HS2 to develop and disseminate learning legacies and would be open to supporting here as well.

- Accountability – we're keen to see continued liaison with the Scottish Parliament, particularly the Public Audit Committee, to ensure projects remain on scope, on time and on budget
